**BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF AND OVERHEAD:**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.) This fee includes the following: Personnel available 24 hours a day, 365 days a year to respond to initial call, arrangement conference. Coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased. Clerical assistance in the completion of various forms and permits associated with a funeral. Also covers overhead, including facility maintenance, equipment and inventory costs, insurance and administration expenses, and governmental compliance. .... \$1,495.00

**PREPARATION OF THE BODY:**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial

**FORWARDING REMAINS TO ANOTHER FUNERAL HOME:**

This charge includes use of preparation room, basic services of staff, embalming, bathing and handling of remains, transfer of the remains to the funeral establishment, transportation to or from local airport or other place of shipment within a 30-mile radius, additional mileage will be charged at \$3.60 per mile, and obtaining necessary authorizations. This charge does not include visitation or ceremonies. This charge applies to shipment within the continental U.S.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME:**

This charge includes basic services of staff, transportation of remains to cemetery or crematory, transportation to or from local airport or other place of shipment within a 30-mile radius, additional mileage will be charged at \$3.60 per mile, and obtaining necessary authorizations. This charge includes preparation of body, for a visitation, or ceremonies..... \$2,195.00

**GRAVESIDE SERVICE:**

This charge includes transfer of the remains to the funeral establishment, use of preparation room, basic services of staff, refrigeration, bathing, and handling of remains, transport of the remains to the cemetery within a 30-mile radius. This charge does not include visitation or ceremonies. .... \$2,525.00

**IMMEDIATE BURIAL:**

Our charges for immediate burial without rites or ceremonies at the mortuary, graveside, or elsewhere include: Basic Professional Service Fee, transfer of the remains, refrigeration transportation to cemetery and services of staff, within a 30-mile radius, additional mileage will be charged at \$3.60 per mile: .....\$2,195.00

**DIRECT CREMATION:**

Our charges for a direct cremation (without ceremony) include Basic Professional Service Fee, transfer of the remains, refrigeration, and crematory fee. State of California does not require a casket for a cremation, does require an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are alternative containers.
